



Privacy Policy

Ibiza OrgaNICE (NICE) takes the responsibility to respect and protect your privacy and look after your personal data. In this Privacy Policy is explained what personal data is collected, how your personal data is used, reasons possibly needed to disclose your personal data to others and how your personal data is stored securely.

Please note that Ibiza OrgaNICE may be both data controller and data processor for your personal data under certain circumstances.

What is Ibiza OrgaNICE?

Ibiza OrgaNICE is an event planner for (corporate) groups visiting Ibiza, based in Ibiza with correspondence address at Apartado Correos 337, 07815 Sant Miquel de Balansat, Ibiza, Balearic Islands, Spain.

How the law protects you

Data protection laws state that Ibiza OrgaNICE is only able to process personal data if there are valid reasons to do so. The basis for processing your personal data includes your consent (by requesting information or our services), coming to an agreement of the requested services, to enable billing and remittance, and to contact you for customer service purposes.

How does Ibiza OrgaNICE collect personal data from you?

We receive information about you when you visit the website, www.ibizaorganice.com, complete our online contact form, if you contact us by phone, email, or otherwise in respect to any of the NICE services.

If you provide Ibiza OrgaNICE with personal data about a third party (for example when confirming services with Ibiza OrgaNICE on behalf of your client), you warrant that you have obtained the express consent from this third party for the disclosure and use of their personal data.



What type of data is collected from you?

The personal data collected from you may include your name, address, email address, phone numbers, ID details and IP address.

Ibiza OrgaNICE may also keep details of your visits to our website and your queries and correspondence will be saved, in the event you contact us in the future.

How is your data stored?

Ibiza OrgaNICE is obliged to store your data in a register, which can at any time be accessed, modified or -on clients' request- deleted.

All information you provide to us is stored on secured computers and in a secured business cloud. By providing your data you agree to this storage. Ibiza OrgaNICE will ensure that reasonable steps are taken to protect your data in accordance with this privacy notice.

As the transmission of information via the internet is not completely secure, the security of your data transmitted to our site is not guaranteed and any transmission is at your own risk. Ibiza OrgaNICE will use strict procedures and security features to try to prevent unauthorised access.

How is your data used?

Ibiza OrgaNICE uses information about you in the following ways:

- To process requests that you have submitted to NICE
- To provide you with services
- To comply with contractual obligations NICE has with you
- To help identify you and any accounts you hold with NICE
- To enable NICE to review, develop and improve the website and services
- To provide customer care, including responding to your requests if you contact NICE with a query
- To administer accounts, process payments and keep track of billing and payments



- To detect fraud and to make sure what you have communicated is correct
- To carry out marketing and statistical analysis
- To review job applications
- To notify you about changes to the NICE website and services
- Legal requirements by Spanish Authorities
- To provide you with information about services that you request from NICE or which may interest you, where you have consented to be contacted for such purposes
- To inform you of service and price changes

Retention periods

We will keep your personal data for the duration of the period you are a client of Ibiza OrgaNICE. We shall retain your data only for as long as necessary in accordance with applicable laws.

On the closure of your account, we may keep your data for up to 7 years after you have used the NICE services. Ibiza OrgaNICE may not be able to delete your data before this time due to legal and/or accountancy obligations. NICE may also keep it for research or statistical purposes. Your personal data shall only be used for these purposes stated herein.

Who has access to your personal data?

Only the employees of Ibiza OrgaNICE have access to your personal data. Your data is processed for administration, billing, support and the provision of services. Additionally, to provide user (client) and connection details for the service.

Ibiza OrgaNICE works closely with a number of third parties (suppliers). These third parties may collect information about you including name, address, email address, phone numbers, ID details. Only for the purpose for the provision of services on the behalf of Ibiza OrgaNICE.



For the avoidance of doubt, Ibiza OrgaNICE does not and never shall sell your personal data to third parties for marketing or advertising purposes.

Your rights

You have the right to object to the above mentioned use of your personal data, or ask to delete, remove or stop using it if there is no need for NICE to keep it. This is known as your right to be forgotten. There are legal and accountancy reasons why your data needs to be saved, but please do inform NICE if you think your personal data are retained or used incorrectly.

In preventing the use or processing of your personal data, it may delay or prevent NICE from fulfilling the contractual obligations to you. It may also mean that NICE is unable to provide its services or process the cancellation of your service.

You have the right to ask your personal data is not processed for marketing purposes. If you choose not to receive marketing communications from NICE, you will have the choice not to choose these by sending an email to nice@ibizaorganice.com.
